Commissioner Menge made a motion, supported by Commissioner Niemela to approve the payment of the Prepaid Bills and Trust and Agency Accounts for the period of July 15, 2025 through August 11, 2025 in the amount of \$453,328.82. On Voice Vote, the motion carried.

Commissioner Niemela made a motion, supported by Commissioner DeLeon to approve the Sheriff's Dept. Checking Account expenditures for July 2025 in the amount of \$9,900.87. On Voice Vote, the motion carried.

UNFINISHED BUSINESS:

Chairman Dakota apologized for missing the July meeting. He thanked the Board for waiting for him to be in attendance so that he could cast his vote. He opened the table for Board members to present their opinions/concerns regarding the FLOCK Safety, License Plate Recognition product. He then opened the topic for public comment. Sheriff Brogan stated how the LPR product had recently aided the Sheriff's Department in locating a stolen vehicle and brought a juvenile home safely. Much discussion followed. Commissioner DeLeon made a motion to enter into an agreement with FLOCK Safety to purchase the License Plate Recognition software/camera system. The motion died for lack of support. Commissioner Niemela made a motion, supported by Commissioner Menge to reject the purchase of the FLOCK Safety, License Plate Recognition software/camera system. On Roll Call Vote, the motion carried. Roll Call Vote was as follows: Yeas: Commissioner Niemela, Commissioner Kent and Commissioner Menge. Nays: Commissioner DeLeon. Chairman Dakota placed his vote on record as a nay vote.

ACTION ITEMS:

Commissioner Kent made a motion, supported by Commissioner DeLeon to approve the annual membership with the Baraga County Convention and Visitors Bureau in the amount of \$150.00. Before the vote Commissioner Kent voiced concerns that the BC CVB is evaluating their role in the involvement of the CVB the operations of the Pinery Ski Trails. Some discussion followed. On Voice Vote, the motion carried.

Commissioner Menge made a motion, supported by Commissioner Kent to make a \$20,000.00 to the Baraga County RHVF (Health Benefit Trust Account) for FY2025. On Voice Vote, the motion carried.

Commissioner Kent made a motion, supported by Commissioner Niemela to approve the Cost Participation Agreement with the Baraga County Road Commission for MSP State

Disaster Contingency Funds for the disaster relief funds related to the flash flood that occurred on May 15, 2025. On Voice Vote, the motion carried.

Commissioner Niemela made a motion, supported by Commissioner DeLeon to send a Letter of Support on behalf of the Baragaland Senior Citizens, Inc., Senior Meals program to UPCAP. On Voice Vote, the motion carried.
