## **REVIEW OF CLAIMS AND ACCOUNTS:**

Commissioner Menge made a motion, supported by Commissioner Cichosz to approve the BCMH Trustee Per Diem for August 2024 (\$990.00). On Voice Vote, the motion carried.

Commissioner Cichosz made a motion, supported by Commissioner Kent to approve the payment of the Claims and Accounts for the period of August 13, 2024 through September 9, 2024 in the amount of \$47,964.92. On Voice Vote, the motion carried.

Commissioner Menge made a motion, supported by Commissioner Cichosz to approve the payment of the Prepaid Bills and Trust and Agency Accounts for the period of August 13, 2024 through September 9, 2024 in the amount of \$886,644.52. On Voice Vote, the motion carried.

Commissioner Cichosz made a motion, supported by Commissioner Kent to approve the Sheriff's Dept. Checking Account expenditures for \$6,871.44. On Voice Vote, the motion carried.

## **ACTION ITEMS:**

Commissioner Kent made a motion, supported by Commissioner Menge to send a letter of support to UP Area Agency on Aging on behalf of the Baragaland Senior Citizens' efforts to reinstate and maintain the Senior Meals program. On Voice Vote, the motion carried.

Commissioner Menge made a motion, supported by Commissioner Cichosz to appoint Commissioner Kent to the Snowbelt Transit Commission. On Voice Vote, the motion carried.

Commissioner Cichosz made a motion, supported by Commissioner Kent to authorize County Clerk Wendy J. Goodreau to submit the Application for Waiver of Underfunded Status (Retirement Health Benefit System) for the Baraga County Retiree Medical Plan. On Voice Vote, the motion carried.

Commissioner Kent made a motion, supported by Commissioner Cichosz to approve to approve a deposit in the amount of \$16,226.95 into the Baraga County RHVF (Health Benefit Trust Account) for the FY2024. The funds to come from the LATCF. On Voice Vote, the motion carried.

Don Elmblad presented the Board information on GMRS radio receivers. The receivers would allow individuals with much needed communication access, via mobile radio, in areas without cell service. Mr. Elmblad said the one he had approximately a 7 mile range from the receiver. Mr. Elmblad is asking the Board to consider funding a few receivers throughout areas that lack adequate cell service. No action was taken.

Commissioner Cichosz made a motion, supported by Commissioner Kent to set Probate Court part time employee, Nada Wakeham's wage at \$21.95/hour, pursuant to Judge

Brennan's CJO appointment, which is outside of the Personnel Handbook, for the time-period July 7, 2024 – September 30, 2024. On Voice Vote, the motion carried.

Commissioner Cichosz made a motion, supported by Commissioner Menge to approve an additional \$900.54 of ARPA funds for additional electrical work completed by TC Electric while working on the LED Lighting installation. On Voice Vote, the motion carried.

Commissioner Menge made a motion, supported by Commissioner Cichosz to approve an additional \$564.46 of ARPA funds for additional work completed by Mike Whitman as part of the improvements to the Pole Building (Doors/Frames) at the Sheriff's Dept. On Voice Vote, the motion carried.

Commissioner Cichosz made a motion, supported by Commissioner Kent to approve a KBIC 2% Funding request on behalf of the Baraga County Veterans' Affairs' Department. On Voice Vote, the motion carried.

Mr. Bill Delene, Trustee of the Markus J Ladd Revocable Trust, was present to discuss land in Arvon Township that is to be gifted to the County, with conditions, from the Trust. Mr. Delene said there is a mortgage on the property and that the County would be obligated to assume the debt. The land is appraised at \$860,000 and the debt is approximately \$580,000.00. If the County does not accept the bequest the land will be sold to private ownership. No action was taken.
