- \$.45/hour for hourly FTE and PTE and non-department head salary positions.
- \$2.00/hour for Corrections & Sheriff Deputy contracted employees along with Undersheriff David Miller and Jail Administrator Jon Boever.
- 2% wage increase for Elected Officials and Department Heads with an additional \$1,800 for Joseph O'Leary, Joe Brogan and Patrick Osterman.

Commissioner Cichosz made a motion, supported by Commissioner Menge to approve the purchase of a new copy machine from The Office Planning Group, for the Administration Building, not to exceed \$6,281.60, with funds from the Local Assistance and Tribal Consistency Fund. On Voice Vote, the motion carried.

Commissioner Dakota made a motion, supported by Commissioner Cichosz to authorize a 2% monies request from the Baraga County Veterans' Affairs Committee to the Keweenaw Bay Indian Community. The funds will be passed through the County to the Veterans' Affairs for the Veteran Spring Festival. On Voice Vote, the motion carried.

Sheriff Brogan reported that he reached out to Bay Ambulance regarding the purchase of AED for the patrol cars and Sheriff's Department and the ones that were approved for purchase at the September 2023 regular meeting are not compatible with the ones Bay Ambulance uses. Commissioner Dakota made a motion, supported by Commissioner Cichosz to approve the

purchase of AED equipment that will be compatible with Bay Ambulance AEDs in the amount of \$6,719.25 for the Sheriff's Department. The AED equipment will be paid with funds from the Local Assistance and Tribal Consistency Funds.
