(b) Approve sign choice

Discussion: Need to read the lease. Jamie found a source for a 24"x36" metal sign at \$130, and electronic sign for \$150. Dan found a source (Random Things Unlimited) for a sandwich sign with \$15-\$20 per slat.

Discussion: The Chamber's \$30,000 CD matures 6/4/24. Current balance is \$30.628.76.

Action: Motion to reinvest \$15,000 in a 5 month CD with SNB and to reinvest the balance in an 11 month CD with SNB with all interest to be rolled over by Trevor Juntunen, supported by Dan Mares. All in favor.
