

BARAGA COUNTY ELECTION NOTICE

Notice is hereby given that a Primary Election will be held in Baraga County on **TUESDAY, AUGUST 4, 2026**

TO THE QUALIFIED ELECTORS: Of the Baraga County, Townships of: Arvon, Baraga, Covington, L’Anse and Spurr.

PLEASE TAKE NOTICE that the following proposals and races will appear on the ballot:

LOCAL PROPOSALS	BARAGA TOWNSHIP “Shall the tax limitation on general ad valorem taxes within Baraga Township imposed under Article IX, Sec. 6 of the Michigan Constitution be increased for said Township by 1.5 mills (\$1.50 per \$1,000 of taxable value) for the period of 2026 through 2029 inclusive for Fire Operating and Equipment, and shall the Township levy such increase in millage for said purpose, thereby raising in the first year an estimated \$ 217,232?”
COUNTY-WIDE	ROADS AND STREETS “Shall an ad valorem tax of two (2) mills (\$2.00 per \$1,000.00 of taxable value) over and above the rate of taxation now in effect be levied upon all property within Baraga County, Michigan for a period of 5 years, from 2027 to 2031 inclusive, to provide funds for the purpose of providing tax money with which to make necessary improvements and construction of primary and local roads in the County Road System, including streets in the Village of L’Anse and the Village of Baraga, within the County of Baraga, which would raise in the first year an estimated \$798,901.58? (this is a RENEWAL of the millage proposal which will expire in 2026)”
RACES	Governor, Representative in Congress 1 st District, Representative 109 th District, State Senator 38 th District, County Commissioner, District 5 (Partial Term Ending 12/31/2028), County Treasurer (Partial Term Ending 12/31/2028) and Convention Delegates.
