

**BARAGA COUNTY ELECTION NOTICE**

Notice is hereby given that a General Election will be held in Baraga County on **TUESDAY, NOVEMBER 5, 2024**

**TO THE QUALIFIED ELECTORS:** Of the Baraga County, Townships of: Arvon, Baraga, Covington, L’Anse and Spurr.

**PLEASE TAKE NOTICE** that the following proposals and races will appear on the ballot:

<b>TOWNSHIP PROPOSALS</b>	<b>ARVON TOWNSHIP SCHOOL</b> Shall the limitation on the amount of taxes which may be assessed against all property, exempting therefrom homestead and qualified agricultural property as defined by law in Arvon Township School District, Baraga County, Michigan, be increased by 18 mills (\$18.00 on each \$1,000.00 of taxable valuation) for a period of 4 years, 2025, 2026, 2027, and 2028, to provide funds for operating purposes; the estimate of the revenue the school district will collect if the millage is approved and levied in the 2024 calendar year is approximately \$685,157.20.

JUDICIAL: Justice of the Supreme Court, Judge of Court of Appeals, 4 <sup>th</sup> District, Judge of Circuit Court, 12 <sup>th</sup> Circuit, Judge of Probate Court. LOCAL SCHOOL BOARD: Arvon Township School, Baraga Area Schools and L’Anse Area Schools. VILLAGE: Baraga Village President, Baraga Village Trustee, L’Anse Village President, and L’Anse Village Trustee.
