Registration forms can be obtained at www.mi.gov/vote and mailed to the Township Clerk. Voters who are already registered may update their registration at www.expressSOS.com.

The last day to register in any manner other than in-person with the local Clerk is **Monday, July 20, 2026**. After that date, anyone who qualifies as an elector may register to vote in person with proof of residency (MCL 168.492) at the following:
